

Terms and Conditions Governing the CIMB TravelEASE Promotion 2019 (“Promotion”)

Eligibility

1. This CIMB TravelEASE Promotion 2019 (the “**Promotion**”) is organised by Sompo Insurance Singapore Pte. Ltd. (“**Sompo**”) and CIMB Bank Berhad, Singapore Branch (“**CIMB Bank**”).
2. The Promotion period is from 1 May 2019 to 15 July 2019 (the “**Promotion Period**”).
3. The Promotion is applicable to participants who submit an application via a CIMB Bank Dedicated Channel as defined in clause 5 below, successfully purchase a TravelEASE Plan (“**TravelEASE**”) and have TravelEASE issued during the Promotion Period.
4. Each participant who purchases TravelEASE in accordance with clause 3 above shall be entitled to a 55% discount off the premium for a single trip plan and /or 20% discount off the premium for an annual multi-trip plan.
5. A “CIMB Bank Dedicated Channel” means:
 - a. Online application on CIMB Bank website via <http://www.cimbbank.com.sg/en/personal/products/insurance/general-insurance/travelease.html>; or
 - b. Physical application form submitted or mailed in to either of the following CIMB Bank Branches:
 - i. 270 Orchard Road #03-02, Singapore 238857;
 - ii. 50 Raffles Place, #01-02 Singapore Land Tower, Singapore 048623; or
 - c. Physical application form mailed in to Sompo at 50 Raffles Place #05-01/06, Singapore Land Tower, Singapore 048623. The application form is deemed submitted upon Sompo’s actual receipt of the same.

General

1. Each of CIMB Bank and Sompo reserves the right in its sole and absolute discretion to determine whether a participant is eligible for the Promotion. If CIMB Bank and/or Sompo determines that a participant is not eligible, CIMB Bank and/or Sompo reserves the right not to allow the participant to participate in the Promotion.
2. By participating in the Promotion, all participants agree and consent that CIMB Bank and/or Sompo may use, disclose and process personal data (whether contained in the application form or otherwise obtained) provided by them for one or more of the purposes stated in CIMB Bank’s Terms and Conditions Governing Personal Data Protection Act (PDPA) 2012 (available on www.cimbbank.com.sg) and for the purposes stated below and all participants confirm that they have read and agree to be bound by the terms stated therein, as may be amended, supplemented and/or substituted by CIMB Bank from time to time:
 - a. disclosing the personal data of the participants to Sompo in connection with the Promotion;
 - b. administering and conducting the Promotion;
 - c. processing of the application for TravelEASE and administering TravelEASE; and/or
 - d. providing marketing material and information sent by Sompo on their products and services via ordinary post, electronic mail, text message and/or phone call.

Each of CIMB Bank and Sompo reserves the right to terminate or suspend the Promotion or amend, revoke, vary, delete or add to any of these terms and conditions at its absolute discretion at any time without any liability and such changes shall be binding on participants with effect from the earliest of the following:
 - a. the date CIMB Bank places notice of such changes on its Singapore website;
 - b. the day after CIMB Bank sends notice of such changes to the participant's last known address in the records of CIMB Bank by ordinary post;
 - c. the day after CIMB Bank sends notice of such change to the participant by short messaging system (SMS) or electronic mail; and/or
 - d. the date CIMB Bank places such notice at all of its branch(es) in Singapore.
4. Any termination, suspension, amendment or variation of the Promotion or the terms and conditions herein by CIMB Bank or Sompo shall not entitle any participant to any claims or compensation from CIMB Bank or Sompo for any and all losses or damages suffered or incurred by that participant, whether directly or indirectly caused.
5. Each of CIMB Bank and Sompo shall not be liable in any manner for any consequence, claims, losses, damages, injuries, liabilities or expenses suffered or incurred arising out of or relating to, the Promotion, whether directly or indirectly caused, including but not limited to any hardware or software breakdown, malfunction or defects in any computer system or equipment and/or any incomplete, lost, late, damaged, illegible or misdirected notices, letters, application forms and/or correspondences.
6. The Promotion is not valid in conjunction with other promotional offers unless otherwise stated.
7. Each of CIMB Bank's and Sompo's decision on all matters relating to the Promotion will be at their absolute discretion and shall be final, conclusive and binding on all parties. No further correspondence or claim will be entertained.
8. All feedback, dispute and correspondence in relation to the administration of the Promotion shall be directed to and resolved directly with Sompo. CIMB Bank shall not be liable for any loss, injury, claim or damage suffered or incurred in relation thereto and shall not be obliged to enter into any correspondence on any matter with any party concerning the Promotion.
9. CIMB Bank is not a supplier of TravelEASE and will not accept any liability in relation thereto.
10. In the event of any inconsistency between these terms and conditions and any other terms and conditions, application form, brochure, promotional or marketing material relating to the Promotion, these terms and conditions shall prevail to the extent of matters relating to the Promotion.
11. These terms and conditions shall be governed by the laws of Singapore and the participants in the Promotion irrevocably submit to the non-exclusive jurisdiction of the courts of Singapore.
12. A person who is not a party to any agreement governed by these terms and conditions shall not have any right under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce any of these terms and conditions.
13. All information is correct at the time of printing.
14. TravelEASE is underwritten by Sompo and distributed by CIMB Bank.
15. TravelEASE is protected under the Policy Owners' Protection Scheme which is administered by the Singapore Deposit Insurance Corporation (SDIC). Coverage for your policy once issued is
