

TERMS AND CONDITIONS GOVERNING CIMB BANK SINGAPORE X THE COLOR RUN FACEBOOK CONTEST 2017

1. The CIMB Bank X The Color Run (TCR) Facebook Contest 2017 ("Contest") is organised by CIMB Bank Berhad, Singapore Branch ("CIMB Bank" or "Bank") and consists of three (3) online games that will take place in different periods as follows, in conjunction with the respective actual race ("Event") to be held in three countries:

(with each period known as the "Contest Period").

ELIGIBILITY

- 2. This Contest is open to Singaporeans, Singapore Permanent Residents and Employment/ Dependent Pass Holders residing in Singapore, above 18 years of age as at 1 July 2017 ("Eligible Participants").
- 3. The Eligible Participants must not be an employee of the Bank. These include:
 - Permanent and/or contract employees of CIMB Bank; and
 - CIMB Bank's representatives and/or agents, including but not limited to advertising and promotion agents and vendors who are directly involved in this Contest.
- 4. An Eligible Participant is limited to one (1) entry ("Entry") per Contest Period.
- 5. An Eligible Participant needs to be an existing Facebook user with at least 100 friends and the Facebook account must have been set up before 1 January 2017.
- 6. All the following criteria must be met by each Eligible Participant to be considered a successful Entry into the Contest, per each Contest Period:
 - log in to the game during the Contest Period of your choice, using one's personal Facebook account. Only entries received by the Bank via the official Contest page (http://cimbbank.sg/2t9OXM0) during the Contest Period will be eligible for the Contest.

SELECTION OF WINNERS

7. The Bank will select one (1) Grand Prize winner with the most creative answer to the question posed per online game, from the list of the "Top 20 Color Runners" leaderboard at the end of each Contest Period. The remaining 19 in the "Top 20 Color Runners" leaderboard will be entitled to the Consolation Prizes. The Bank's selection is final and done in its sole and absolute discretion. No queries, correspondence, claims, challenges or appeals will be entertained regarding the Bank's decision on the same.



NOTIFICATION OF WINNERS

8. CIMB Bank will notify the winners of each Contest Period at the email address ("Email Notification") submitted in the Contest form as provided by the Eligible Participants.

Grand Prize Winners

- 9. Within 48 hours from the time of the Email Notification, the Grand Prize winner is required to reply to the email address of the Email Notification, providing the following details:
 - Full Name (as stated in one's NRIC or FIN or Passport).
 - NRIC or FIN or Passport number,
 - · Date of Birth,
 - Address of Singapore residence,
 - Contact Number

of both the Grand Prize winner and that of his/her companion participating in the Event in order to claim the Grand Prize.

- 10. If the Grand Prize winner does not provide the requisite information in clause 9 above as required by CIMB Bank, within the stipulated time period of 48 hours from the time of Email Notification, or is unable to attend the Event in person, he/she will be deemed to have forfeited all rights to the Grand Prize.
